

OWNERS ELIGIBILITY DECLARATION FOR NEW JERSEY BRED HORSES

Please complete this form, to verify that your horse is New Jersey Bred, and eligible to participate in the New Jersey Bred All Breed Show; and eligible for nomination into the Jerseybred Year End Awards program. Please send completed form and a copy of the horse's Registration Papers to the Jerseybred Chairperson listed below. Upon receipt of this form, you will be sent a "NEW JERSEY BRED PERMANENT CERTIFICATION - NON RACING BREEDS" Certificate. This certificate will be the horse's permanent proof of eligibility, & need not be done each year.

DO NOT SEND THIS FORM IF YOU ALREADY HAVE A CERTIFICATE

A NEW JERSEY BRED HORSE IS DEFINED AS:

1. Any foal dropped in the state of New Jersey, except for transient mares. A mare will be considered to be a transient mare if she does not reside in the State of New Jersey for at least 120 consecutive days, including the day of foaling. The owner of a mare may be asked to submit proof of such residence to the individual breed group; (or)
2. Any foal resulting from an embryo transfer from a mare who resides 120 consecutive days in the State of New Jersey, providing blood typing of the mare, stallion, and foal is carried out to authenticate parentage; and embryo transfer is agreeable to the national registry of the breed. A mare must donate only in New Jersey; (or)
3. The get of any stallion standing in New Jersey the full breeding season of the year in which the foal was conceived. Stallions standing in New Jersey must breed only in New Jersey for any yearly breeding season; (or)
4. Foals resulting from transport of semen from a stallion standing the full season in the State of New Jersey, providing blood typing of the stallion, mare, and foal is carried out to authenticate parentage; and semen transport is agreeable to the national registry of the breed.
